Blue Haven Pools - Variance Application to Install a Pool at 1624 Salem Lane, TMP No. 36-1. 015-084 - Property Owners Richard & Ann Krisher

Zoning Hearing Board application for Blue Haven Pools. The subject property is owned by Richard and Ann Krisher, 1624 Salem Lane, Tax Map Parcel No. 36-015-084. The subject property lies

within the (SRL) Suburban Residential Low Zoning District (within the Sweetbriar Subdivision) which was approved as a B6 Single-Family Detached Cluster under the 1975 Quakertown Area Zoning Ordinance. The applicant is seeking the following variances for the proposed In-Ground Pool and Patio:

1. A variance from Article V. Section 502. (c) the 1975 Quakertown Area Zoning Ordinance permits a maximum allowable impervious surface of 20%. The existing nonconforming impervious surface is 42.38%. The applicant is seeking a variance to increase the on lot impervious surface to 49.60%.

2. A variance from 27-514. D. to disturb steep slopes between 8-15% (maximum disturbance 40% 1,952 sf) (proposed disturbance 73% 2,683 sf) and a variance to disturb steep slopes 25% or steeper (maximum disturbance 15% 25 sf) (proposed disturbance 21% 121 sf)
3. A variance from Section 23-603. A. of the Floodplain Management Ordinance - to permit fill within the floodplain.

The ZHB Application was stamped Administrative Complete on February 23, 2024. The 60-day MPC timeframe is set to expire on April 22, 2024. The Zoning Hearing Board meeting is scheduled for Thursday, March 21, 2024.
