#### A Guide to Supplemental Bird Feeding

In the last issue of the Richland Township Newsletter, Bird Town shared with you the importance of growing native plants on your property. Native plants support birds by providing them with nutritional seeds and berries, and they also provide birds with protein rich caterpillars for their young. As we move into the fall, native plants are a rich source of food for them both in the fall and winter months – if you don't deadhead your native flowers.

You may want to consider helping your backyard birds, and birds that will be migrating through your area on their way south, with supplemental food. Not only will you be helping your feathered neighbors, but watching birds at the feeder is a joyful hobby for many.

When it comes to feeding birds, you have many options both in feeder types and food and it all depends on the types of birds you want to attract. Placement of the feeder is also important. Audubon recommends that to avoid crowding, and to attract the greatest variety of species, provide table-like (platform feeders) for ground feeding birds, hopper or tube feeders, and suet feeders well off the ground for woodpeckers, nuthatches, and chickadees. You don't have to spend a lot of money on a feeder, but the cost will go up as you get more elaborate say for squirrel proof feeders, or feeders that keep large birds like starlings out.

If you want to attract a variety of birds, try a variety of seeds in different feeders or buy a blend. Experiment. Many manufacturers market certain blends of seeds for birds such as for songbirds or finches. Blends are probably the best way to get started to see what the birds in your backyard like. Whole unsalted peanuts, and peanut pieces are loved by blue jays, woodpeckers, titmice, nuthatches, and chickadees.

By taking care of your backyard birds, you'll get hours of enjoyment and helping them during a time of year when food sources are not as plentiful. You may even consider joining Project Feeder Watch, a Cornell Lab of Ornithology citizen science project, where you monitor and record your backyard birds from November through April (feederwatch.org). Please keep in mind that our schedule may be affected by weather or other factors.

#### **Important Tips**

- DO NOT place any other materials such as sticks, grass clippings, or yard waste with your leaves. These items clog the vacuum hose and cannot be collected. ONLY leaves will be collected, all other waste will be left behind.
- DO NOT park vehicles on or close to leaf piles. Hot mufflers and exhaust pipes may ignite the leaves and cause vehicle damage or loss. We cannot collect leaves that are under or too close to vehicles. We need room for our equipment to be able to get to the piles.
- A leaf drop-off area is available for all residents behind the salt shed at the Township Building.
- WE NO LONGER ACCEPT LEAVES IN PLASTIC BAGS AT THE DROP OFF BIN. Please dump bags out onto the pile and take the plastic bags with you. Leaves in paper bags are accepted.

#### Snow and Ice

Snow and ice conditions affect all of us at the same time. While we can't be everywhere immediately, we work very hard to keep the roads passable throughout the storm.

#### **Important Safety Tips for Winter**

- When snow is in the forecast, keep your cars off the roadways and park them in your driveways.
- Give plow trucks the right of way.
- When cleaning sidewalks and driveways, always throw the snow back into your yard.
- If you live on a two-lane street, wait until we have your street plowed back to the curb before cleaning out your driveway entrance.
- Remember, a snow emergency means all vehicles are prohibited from being parked on any Township street and may be towed at your expense, including boats, trailers, and campers.
- Please remove basketball nets from roadways and curb lines.

#### **Championing Accountability**

Hello all. I want to use this article to provide an update on the recent activity in the House regarding the 2023-24 state budget. This was a budget process that was filled with frustrations and saw a lack of accountability from the Governor's office on the issue. I ended up voting no on this budget, and here are a few key reasons why.

#### Failure to Address Financial Pitfalls

This budget does not address the multiple financial pitfalls the state of Pennsylvania will face in the near future. Instead of addressing and dealing with our structural deficit that exists, this budget decides to use our existing surplus funds to "balance" our budget, dragging Pennsylvania closer to a deficit instead of the surpluses we've had in recent years. Financial accountability for our state is crucial and running toward a deficit does not help our state.

#### Veto of Lifeline Scholarships

In an original deal with the Governor, the Senate and Gov. Josh Shapiro agreed on a budget that would include \$100 million dollars for Lifeline Scholarships in Pennsylvania. Lifeline Scholarships allow children in underperforming schools an opportunity to choose their school; however, instead of holding himself accountable and upholding his promise, the Governor went back on his word and instead decided to line-item veto that \$100 million for Lifeline Scholarships.

I also voted against funding for the University of Pittsburgh, Penn State University and Temple University this session for a couple of key reasons. Firstly, even though we would have increased their funding again, none of these institutions pledged to freeze their tuition for the upcoming school year. While Pitt and Penn State froze tuition for their satellite campuses, their tuition rates for main campus have only continued to rise.

At Pitt, tuition has increased over 19% in the last nine years for Pennsylvania students, and after this year's increase it will now cost over \$20,000 dollars for Pennsylvania residents to attend Pitt. That is also not including the 10% and 7% increases that are coming for student housing and meal plans, which is a separate charge from tuition. At Penn State, tuition at its main campus will go up 2% this year and next year for Pennsylvania residents, which would also make tuition at Penn State for Pennsylvania residents cost over \$20,000 dollars a year. Even Temple, which has frozen its tuition prices for the past two years, has decided to raise tuition by 4.2% for Pennsylvania students this year. These institutions are also exempt from Pennsylvania's Right-to-Know laws and are not held to the same level of accountability as the rest of our state universities. I want to make sure we get promises from Pitt, Penn State and Temple that they will be more transparent and that they will freeze tuition prices when we provide them with this funding. These provisions will only help our students and keep our state universities affordable for Pennsylvania students so they can continue to build their lives in this great state we call home.

Finally, I want to remind you about the services my office can provide for you. We are here to assist you with any state-related matters. Services include assistance with PennDOT paperwork, SEPTA Key Senior Fare Card applications (original and renewals), PACE and PACENET applications for seniors, property tax and rent rebate applications, state tax forms and several other state programs.

#### **Ray's Tax Tips**

Many taxpayers ask me about the Property Tax Rebate program available from the Pennsylvania Department of Revenue. This is a program that offers rebates on property tax payments to seniors aged 65 and older, widows and widowers aged 50 and older and qualified disabled person aged 18 and older. As with most programs there are other requirements, so I recommend you contact the Department of Revenue to determine your specific situation. Rebate application forms are available on the Department of Revenue website.

The law was recently changed for 2023 rebates to allow greater access to benefits. Eligibility, other than age, is primarily based on income. The limit on income was increased from \$35,000 to \$45,000 reflecting inflation and will now increase annually equal to the Consumer Price Index.

The amount of the potential payment to you has also increased to a maximum of \$1,000. If you will be applying for the rebate, please send both the Taxpayer Copy along with the Tax Collector Copy when paying your tax bill. Include a self-addressed, stamped envelope and I will return the Taxpayer Copy to you stamped PAID and signed. Please keep track of your receipt in your tax files.

The tax office is here to assist you anytime a property tax question comes up. My website RichlandTC.com offers other useful information, links to relevant websites and the opportunity to pay by credit/debit card or by eCheck.

#### **Preservation Board**

#### Preservation Board Preserves Another Farm with Natural Areas

The Richland Township Land Preservation Board has been focused on the preservation of land in the Nockamixon/Haycock Conservation Landscape that contains the Quakertown Swamp. Heritage Conservancy has made protection of the Quakertown Swamp a priority, and we are now working with them to acquire easements on acreage to help protect the surrounding buffer of wetlands. In 2021, the Quakertown Swamp was recognized as an International Wetland of Distinction that merits protection.

The Preservation Board has completed the process of preserving the second farm in this area through a conservation easement. It is a historic farm located partially within the Quakertown Swamp. With the guidance of Heritage Conservancy, a not-for-profit land conservation organization, Richland

Township received grant allocations through the Pennsylvania Department of Conservation and Natural Resources (DCNR). This funding has paid one-half of the easement value and protects 55 acres in this critical area.

Farmland, critical habitat and significant natural areas will be protected within this Conservation Landscape. Conservation Landscapes were established in 2011 when Ann F. Rhodes and Timothy A. Block of the Morris Arboretum of the University of Pennsylvania updated the Natural Areas Inventory of Bucks County. The Nockamixon/Haycock Conservation Landscape provides habitat for 27 species of reptiles and amphibians. Twenty species of plants that are tracked by the Pennsylvania Natural Heritage Program (PNHP 2010) have been found in the landscape. Quakertown Swamp is also designated as an Important Bird Area by Audubon of Pennsylvania. We are proud to have a part in protecting the habitat that is a home these species.

As well as preserving the valuable soils of the farmland, it is also our goal to protect the riparian corridors - the stream banks and associated lands - of the Upper Tohickon Creek and its tributaries that in turn protects ecological functions like ground water recharge, waste decomposition and biodiversity conservation. This farm contains the Bog Run tributary of the Upper Tohickon Creek, a vital part of our watershed.

The Preservation Board has protected almost 1,400 acres of open space fee simple and easement purchases, as well as several generous donations from landowners. All open space purchases and easements are protected *in perpetuity* through deed restriction and are made possible through the generosity and foresight of the property owners.


If you live in the northeast section of the Township, north of Raub Road and east of the railroad tracks, you will cast your ballot at the Richland Township Municipal Building located on California Road.

#### The Richland Historical Society asks for Community Help: SOS Save Our School

#### From the members of the Richland (One-Room School) Historical Society

For the past few months, a group of local residents has been working to revive the Richland Township (One-Room School) Historical Society. All are former or new members of the Society and would like to reorganize it after the Pandemic led to a shut -down for the past several years. The Society meets on the grounds of the Shelly One-Room Schoolhouse, a one-room school built by Richland Township in 1885, one of nine schoolhouses built by the township. For 72 years, hundreds of children were educated there and went on to build our community.

It took the work of dedicated teachers and residents to save this school when the one-room schools were shuttered in 1957 with consolidation of the school district. They met with the Richland Township School Board to purchase the Shelly School for \$1,388. These people recognized how important it was to preserve this chapter in the educational system in Pennsylvania. The Richland Historical Society was created then and they received their charter in 1959. The Society incorporated and became a 501(c)3 (non-profit) organization. With community support that included contributions from members, local businesses and grants, the Society was able to pay off their mortgage and offer programs to the community, as well as purchase the grain barn next door for a future museum. Tours were also available to students from local schools. The tours explained what a day in the one-room school was like with one teacher and grades 1-8 together. Homecoming was held yearly to bring the former students together again.

The Shelly Schoolhouse looks the same as it did in 1885, the year it was built, with desks for 40 students, blackboards, a pump organ and a potbellied stove for heat. It is a step back in time for sure. It is one of a handful of schoolhouses left, and it is the only fully restored one-room school in Upper Bucks County. The Shelly Schoolhouse is recognized as both a national and local treasure, having been placed on the National Register of Historic Places in 2011, and having been listed on the Bucks County Register for Historical Places.

Once again, as in the past, we ask for community help and support with the reformation of the Society. We need your financial help and volunteer time to get things running again as they were. Consider becoming a member or making a donation to help the Richland Historical Society; there are a lot of things to volunteer to help with. It's time to look for people who would like to join the Historical Society and who are interested in working on projects to identify and protect the school's inventory, organize collections, and to also do some outdoor maintenance. Help is also needed with preserving the local historical documents, photos and artifacts, and any knowledge that you have would be appreciated. One of our big projects this year will be the restoration of the girls' necessary house that is part of the original schoolyard.

The Society currently meets on the third Sunday of every month at 2 PM through December.
